Three new licensees were in attendance at club, so the rest of the members shared what their interests are in ham service and what got them started.

Bill Balsley presented Tulare County's proposed new ordinance regarding restrictions to towers. Specifically aimed at cell towers, however, it also addressed limits to all towers in all County areas. His proposal is to present the County staff with more height limitations acceptable to TCARC as follows:

If the property is one (1) acre or less in size, limit the height of the tower to 90 feet with the antenna above that; if the property is over 1 acre in size, no height limitations. And, when pulling a building permit for construction/installation of a tower, the applicant would have to show his license to obtain the permit, or more restrictive limitations apply.

Steve Lee Thomas W6SLT moved and Pam Drake KA2RQK seconded that the club support this action; motion passed unanimously.

Bill Balsley KG6AIR and any other interested persons will meet with County staff on May 30, 2007, at 1:30 at Tulare County Resource Management Agency offices.

Discussion took place regarding holding a field day event. Marge and Bill Balsley KG6AIR reported that Robby Gill KI6KFZ, KingsKraft, had issued an invitation for members to come to their site to hold a field day event. Dave McElroy WA6BEF asked Marge to contact them to see if that offer was still good, that maybe 5-15 persons might show up. Not as a club sponsored event, but as individuals attending the event at the KingsKraft location. Marge will do so and send e-mail or snail mail to all members.

The repeater transmits at 10 watts in an attempt to eliminate interference with other 2-meter repeaters at the site. They are still attempting to locate the cause of the noise on the Park Ridge repeater. Chuck is also looking for locations on the valley floor for "voting system" receivers.
